May, 2023	District Clerk maintains list of names of those residents who were given absentee ballots. Said list is to be available, upon request, for public inspection until the day of the election.
May 15, 2023	Voting machines set up and delivered by Board of Elections for use by this date.
May 16, 2023	Budget Vote/Board Election Date. Board Meeting to Adopt Budget/Board Vote results.
July 1, 2023	Implement 2023-24 Budget.
